# C Goal of the call for proposal

### **General Goal**

- Support the structuring of international advisory services at HEIs and public and private Brazilian Research Institutes.
- Develop and consolidate internationalisation strategies at HEIs and public and private Brazilian Research Institutes, focussing on capacity building for managers and implementing language policies.

### Specific Goal

- Build capacities of the Brazilian institutions through the exchange of knowledge and experiences between institutions in the United Kingdom and Brazil, at two levels:
  - 1. Structuring of international offices in Brazilian institutions which are starting its institutionalised international actions
- 2. Team development not only at universities and the international offices of the HEIs, but also of key representatives from other areas of the institution, linked to the systemic view of internationalisation aiming to form 'internationalisation agents' within the eligible entities

## $\bigcirc$ Goals of the call for proposal

### **Specific goals**

- Support Brazilian institutions with the creation of their internationalisation plans that include internationalisation strategies and language policies, with the support of UK institutions
- Strengthen strategic partnerships between eligible Brazilian and UK entities.
- Develop tools and training related to the monitoring and evaluation of internationalisation plans
- Improve and/or modify language policies regarding ELL and ELT in Brazil
- Address the main gaps regarding research in ELL and ELT in Brazil, as well as in Internationalisation in Higher Education, seeking to support and improve both policies and practices in these areas.

### **① Expected results**

#### Short term implementation

#### Medium to long-term increase

- Training strategies within the eligible Brazilian
  entities
- Bilateral agreements or initial processes for the establishment of partnerships with British institutions
- Internationalisation strategies and plans in force for Brazilian institutions
- Internationalisation strategies aimed at team development
- Internationalisation strategies aimed at curriculum development
- Internationalisation strategies aimed at language policies

- Opportunities for eligible Brazilian entities to consolidate their internationalisation plans through academic processes and partnerships with British institutions
- Long-term collaboration between eligible British and Brazilian entities to support the transformation of practical English teaching policies in all regions of Brazil.

### **Arranjos institucionais**

Bilateral	Agreement between between a Brazilian institution and a UK institution. Each institution will manage its own resources.				
Trilateral*	Agreement between two Brazilian institutions and a UK institution or vice versa. The resources will be managed by the proposing institutions, according to the budged submitted approved				
Multilateral*	Agreements between two or more Brazilian institutions with one or more UK institutions. This arrangement will only be possible when an institution in the UK works with several Brazilian HEIs, supporting the development of its internationalisation plans and other objectives of this call. The funds will be managed by the proposing institutions, according to the budget submitted and approved.				

\*In the case of trilateral or multilateral arrangements with more than one eligible Brazilian entity, in which there is more than one funding partner for this call, it is possible to request co-funding, provided that it meets the specifications outlined in the budget model and current legislation.

# **Financial support**

The supported item to the approved projects are:

- Consumables
- Equipment and supplies
- Domestic and international flights
- International travel insurance
- Consultancy services necessary for the execution of the Project
- Daily support (according to the FAPs or DIFES)
- Operating costs (if oriented by the FAPs)


It is requested a counterpart from the British and Brazilian institutions that represents at least 15% of total budget. It can be:

- Direct financial resources in the project
- Contribution in kind, such as: infrastructure, scholarship, assistance in conducting workshops, laboratories, and team working hours, amongst others.
